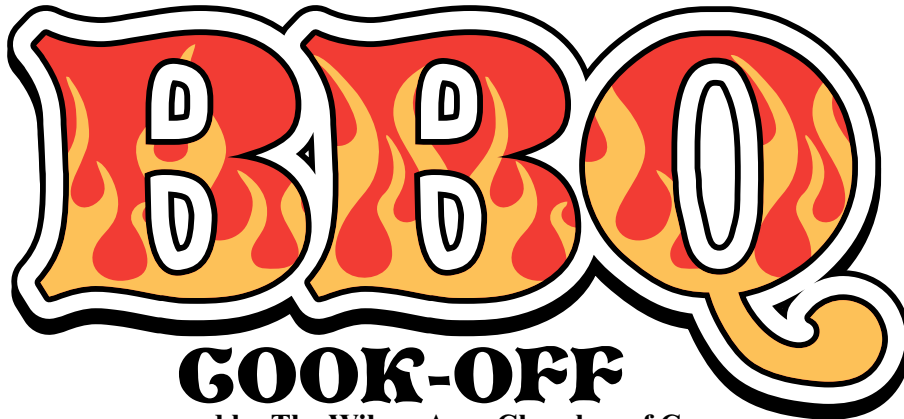

Rules and Regulations April 27, 2019

1. Teams may check-in and set-up between 5:00 p.m. - 7:00 p.m., Friday, April 26th. No grills can be started before 5:30 p.m. Friday, April 26th.
2. Entries for the BBQ Cook-Off will have a \$100 entry fee. Categories are: Rib (beef or pork), Butts, & Chicken.
3. All participants will be given styrofoam boxes for judging on the day of the competition.
4. Head cook must be 21 years of age or older and will be liable for their team.
5. Teams will be accepted on a first come, first serve basis. Cooking sites are 20x20, (2 parking spaces) at Camden Courthouse Square. Participants will be assigned location at time of payment.
6. Teams must supply ALL needed equipment, sanitation supplies and water. If you require electricity, you must provide your own generator. Generators must be turned off by 10:00 a.m. on the day of competition.
7. Fire Extinguishers are REQUIRED at each cooking site.
8. Inspection will be Friday between 5:00 p.m. - 6:00 p.m. Mandatory meetings in the Chamber tent at 6:00 p.m., Friday, April 26th.
9. All meat must be raw/uncooked prior to check-in. Marinating and seasoning prior to check-in is permitted.
10. Sauce must be cooked on meat and not added after removing from grill.
11. Category items being judged are NOT allowed to leave your assigned cooking site and brought back. All meat must be prepared at your designated cooking site.
12. Judging will begin on Saturday at 10:30 a.m. Prizes will be awarded at 1:00 p.m. Judging times will be as follows:
Chicken - 10:30 a.m. Ribs - 11:00 a.m. Butts 11:30 a.m.
1st Place per category: \$500 cash and plaque, 2nd Place per category: \$250 cash and plaque, 3rd Place per category: \$100 cash and plaque. *All 1st Place winners' names will be permanently displayed on a plaque in the Wilcox Area Chamber of Commerce Building at the Gees Bend Ferry Terminal* We will add an overall winner based on how each team finishes in all categories. \$500 will be awarded to the Grand Champion.
13. Tickets will be sold for \$5.00 per person for anyone wanting to judge the Taster's Choice Award.
14. Judging for Taster's Choice will be on Saturday at 10:30 a.m. - 12:30 p.m. Tickets will not be sold prior to 10:30 a.m. or after 12:00 p.m. Taster's Choice results will not factor in Grand Champion Award. 1st Place: \$250 cash and plaque, 2nd Place: \$100 cash and plaque.
15. All cooking sites must be cleaned and vacated by 3:00 p.m. Saturday. Cook sites are approximately 20' x 20' or 2 spaces.
16. Teams for the BBQ Cook-Off will be those persons who have submitted the entry application with paid entry fee and been approved as having satisfactorily met the Rules and Regulations governing the contest.
