



## 13<sup>TH</sup> ANNUAL MARK CURL MEMORIAL BBQ COOK-OFF “STREET FAIR” 2024 Saturday, April 20, 2024

The Wilcox Area Chamber of Commerce’s (WACC) *Mark Curl Memorial BBQ Cook Off*, which is entering its 13<sup>th</sup> year, continues to grow in popularity and size. This regional event includes the cook off, music, food vendors, children activities, Antique Car Show, and a street fair – in conjunction with Black Belt Treasures Cultural Arts Center’s *Hog Wild for Art Festival*.

The street fair is open to artists, craftsmen, and those selling quality items and food products. Booth spaces are available on a first come, first serve basis, and no spaces will be held without completed application and registration fee. WACC reserves the right to reject any application that does not meet WACC guidelines and may infringe on copyright or health and safety laws.

**Vendor Spaces** are located in historic downtown Camden, on flat pavement. Spaces are approximately 12’ x 12’. WACC does not provide any tents, tables, chairs, extension cords, or equipment – vendor is responsible for all booth furnishings. We recommend that vendors with tents bring tent weights – tent stakes are not permitted. Vendors are responsible for cleaning up their space at the end of the event. Garbage receptacles are available throughout the event space.

A limited number of booth spaces with electricity are available on a first come, first served basis.

### Vendor Registration Fee

**Early Bird Registration** - cutoff March 8, 2024 - \$25 WACC Members / \$35 Non-members.

**General Registration** – cutoff April 5, 2024 - \$35 WACC Members / \$45 Non-Members.

**Late Registration** (*if Available*) – after April 5, 2024 - \$45 WACC Members / \$55 Non-Members.

Please make checks payable to Wilcox Area Chamber of Commerce. Vendor Applications must be *received/postmarked* by the above dates to qualify for listed pricing.

If your application is not accepted due to not meeting guidelines, you will be notified within 2 weeks of WACC receiving your application. Application fees will be returned to those not accepted, or if all spaces are filled.

*A \$30 fee will be charged for all returned checks.*

Any cancellations after April 5, 2024 will forfeit their registration fee.

Space is limited, so please read the guidelines carefully, and send in your booth application early!

**Day of Event – Open to Public 9:00 AM – 2:00 PM.** All Vendors must check in at the WACC Tent before setting up. Vendors may begin setting up at 7:30 AM. All vehicles must be removed from the event area by 8:30 am. All booths should be ready to open by 8:45 AM.

Vendor parking areas will be designated at vendor check-in.

This is an outdoor event, which will take place around the Wilcox County Courthouse square and business district. There will be no refunds due to inclement weather.

Vendors may not start breaking down until 2:00 pm, unless otherwise stated by WACC on day of event.

*Vendor is responsible for all aspects of following, collecting, reporting, and paying sales tax(es), in accordance with State, County, and City Laws. The current tax rate is 11% in Camden.*
